

This ANIMAL AND FARM AGREEMENT AND RELEASE FROM LIABILITY CONTRACT 2024 is entered into on this day _____ of _____ in the year 2024 by LA Farmgirls Cow & Cuddle Academy, LLC and includes the volunteers and helpers.

If GUEST is a minor – the parent guardian of Guest _____

In exchange for the ability to visit, enter upon, enjoy, eat at, walk around, support or use the property, facilities, and or interacted with animals including, cows, goats, sheep, bunnies, chickens, or pigs participating in a camp fire, petting/playing/cuddling/yoga with animals, and any other services of the farm, the guest/participant, his/her heirs, assigns, and legal representatives, hereby expressly agree to the following:

1. I agree that the farm activities including but not limited to cuddling, goat yoga, and caring for cows are inherently dangerous activities AND that these activities will expose me to above normal to high risks of bodily injury and/or death, and that I am responsible for my own safety while on the farm property and while engaging in any and all activities. I agree to wash my hand and my child’s hands after touching animals to avoid getting sick.
2. I understand the risks involved in all farm activities and I AGREE TO ASSUME ANY AND ALL RISKS INVOLVED IN GUEST’S USE OF OR PRESENCE UPON FARM PROPERTY AND FACILITIES while engaging in any cow activity and all other activity without limitation and including the risk of death, bodily injury, property damage, falls, kicks, bites, being stepped on, unavailability of emergency care, and/or the ordinary negligence and/or deliberate act of farm or any other person.
3. I agree that LA Farmgirls Cow & Cuddle Academy, LLC and any associated organizations, volunteers, employees, and invitees, (RELEASEES) are NOT liable for any injury to or the death of cow cuddling and/or participant in any other cattle activities or any farm activities resulting from the inherent risks of farm activities.
4. I AGREE NOT TO SUE Farm and/or Releasees in association with ANY claims, damages, costs, or expenses arising out of cow cuddler’s use or visitor, or participant or presence upon farm’s property or hosting venue and facilities while engaging in any and all cattle and farm activities including but not limited to based-on death, bodily injury, illness, and or property damages.
5. Guest and or participant are responsible for complete and full insurance coverage on himself/herself, and personal property. ACCIDENT/MEDICAL INSURANCE: I AGREE THAT: Should emergency medical treatment be required, I and/or my own accident/medical insurance company shall pay for such incurred expenses.
6. Guest/participant’s parent or guardian (if a minor) agree that this agreement and release of liability is a contract that when signed by the parties involved will be legally binding to all parties, subject to the above terms and conditions and shall be enforced and interpreted under the laws of the commonwealth of Pennsylvania.
7. **I actively am aware there are serious risk associated with agritourism (agricultural tourism/ agritainment (agricultural entertainment) activities including but not limited to camp fires, goat yoga, cow cuddling/grooming, and the activities could result in serious to minor illness, bodily injury and or accidental death, and I actively and knowingly and voluntarily assume the risk of these activities.**
8. Guest and or participant assume the risk of cattle, agritourism (agricultural tourism/agricultural entertainment) activities pursuant to Pennsylvania Law.
9. This agreement may be executed in counterparts, each of which shall be deemed an original, but all of which, taken together, shall constitute one and the same agreement.
